UNEMPLOYMENT & SUB PAY INFORMATION

Janesville Assembly is an auto Sub facility, meaning that you do not go on-line or call-in to file a Sub claim while collecting Wisconsin Unemployment Compensation (UC). This could show as an overpayment during an audit. After you exhaust your claims with Wisconsin Unemployment, is when you would be instructed to file with Sub-Pay.

Beware of the following: Be sure to save all Unemployment paper work, sometimes it is needed to process Sub checks. Also, be certain to save all pay stubs from Sub Pay, that way you can keep track if any weeks are missing. If you have outside earning from a part time or full time job, you will have to file a manual paper application for Sub Pay.

CHILD CARE & PARENTING RESOURCE

The on-site UAW-GM Child Care Resource and Referral Consultant will be on-site and available to help you with your family needs and concerns until January 29, 2009. The Dept. of Workforce Development has scheduled dislocated worker orientation sessions for those affected by closures/ reductions related to the automotive industry. These sessions educate people on the resources and services available to them through the Workforce Investment Act (WIA). Attending a session is the first step in the WIA registration process, enabling you to receive training assistance or other supportive services.
