We are writing to ask you and General Motors' Board of Directors to reconsider the announcement to close the Janesville Assembly Plant in 2010.


The State of Wisconsin and GM have had a strong relationship over the last ninety years. During that time, GM has had a number of ups and downs. The state has reciprocated GM's investments in Wisconsin by investing millions of dollars in worker training and infrastructure improvements. Permanently closing your Wisconsin production would end that fruitful partnership.


As you know, over the last decade, GM's Wisconsin workforce has met and exceeded every goal that GM has set for them. There is a very positive relationship between union and management in Janesville. Your workers produce your vehicles at the highest level of quality and productivity while reducing costs and improving safety. You also already have a strong network of local suppliers in Wisconsin. In other words, you have a deeply committed workforce in Janesville that has done its part and stands ready to do what it takes to restore GM's market share.

We recognize that your decision to close the Janesville Assembly Plant was based on gas prices and a related drop in demand for SUVs. We feel that by retooling the Janesville plant or by building a new plant in Wisconsin, GM will be able to utilize its Wisconsin workforce in building a new line of vehicles that meets the changing demands of consumers.

We hope that you will discuss the dedication and excellence of your Janesville workforce, examine the possibility of retooling the plant, and remember the land that is under consideration for the construction of a new plant in Janesville before finalizing any decisions.
